Check before uploading your Doctoral Dissertation to the website !

【Do you need a permit?】

		Your Dissertation contains copyrighted materials or personal information(ex. : beliefs, abilities, physical characteristics, medical history, etc.)
		Have co-author.
		You reproduced the copyrighted work of others in your dissertation.

【1】 Contact the copyright owner and Get your permission agreement in writing.

【2】 Submit a copy of the permission to the Graduate School office.

【Do you need to confirm Submission Guidelines and the contract document?】

		Your Dissertation was published/will be published in the journal.

【1】 Check Submission Guidelines and the contract document to know if publishing on the Internet is available.

The following cases are not allowed to be published on the Internet.

- Where duplicate publication is prohibited.
- When the publisher retains the right to reproduce it.

If you do not have Submission Guidelines and the contract document, ask the Publisher directly.


【2】 Please send Submission Guidelines and the contract document to the Graduate School Office.

◎When the full text of the doctoral dissertation cannot be published on the Internet.

In the following cases, the full text of the doctoral dissertation cannot be published on the Internet.

- You didn't get permission from the copyright holder.
- You plan to get permission from the copyright holder, but it will take more than a year to get permission.
- You plan to publish your doctoral dissertation, but you haven't decided on a publisher.
- Your rights are violated if you publish your doctoral dissertation on the Internet.

⇒ Instead of the full text of your doctoral dissertation, publish the chapter abstracts on the Internet.

【1】 Please write the chapter abstracts.

【2】 Please submit full text of your doctoral dissertation (or the book if it has been published), the chapter abstracts, the abstract of thesis and the application form for non-registration of the full text to the graduate school office.

※The abstract of thesis , abstract of assessment result and the chapter abstracts will be posted on the Kokushikan University website.

※The Graduate School Division will send the full text PDF or booklet to the National Diet Library.

※If someone wants to read your doctoral dissertation, they can read it at the National Diet Library or at the Kokushikan university.

※If it becomes possible to publish the full text on the Internet, please contact the Graduate School Division.
